The client's responsibilities are to properly supervise Assigned Employees; to be responsible for and to safeguard all aspects of its business; to provide safe working conditions; and to exclude Assigned Employees from its benefit plans, policies, and practices. Non-Hire and Conversion Fees. (a) Without Company's written consent, during the period that Company is providing services to Client and for twelve (12) months thereafter and except through Company, Client shall refrain from soliciting, hiring or accepting services or work from any person who is proposed to Client by Company or who at any time provided services through or on behalf of Company, except where the parties have otherwise agreed in writing or upon the payment of a conversion fee equal one percent (1%) for each \$1,000 of the converted personnel's first year gross compensation, up to a maximum percentage of thirty-five percent (35%). (b) Notwithstanding the foregoing, the conversion fee is payable if Client hires a Company employee assigned to Client, regardless of the employment classification, on either a permanent, temporary (including temporary assignments through another agency) or consulting basis within one year after the last day of the assignment. Client also agrees to pay a conversion fee if Company employee assigned to Client is hired by a subsidiary or other related company or business of as a result of Company referral of Company employee to that company.
